Subject: General Services Administration Acquisition Manual; GSAR Case 2024-G502,
Information Collection Reference Correction

1. Purpose. This order transmits a revision to the General Services Administration Acquisition Regulation (GSAR) to correct information collection references in a clause that pertains to leasing, as well as correct the GSAR's reference table for Office of Management and Budget (OMB) Control Numbers.
2. Background. There are two actions captured in this case.
 1. Update the GSAR table at 501.106 to reflect the most current information collection references and OMB Control Numbers.
 2. Update the OMB Control Number referenced in GSAR provision 552.270-1.

This revision is taken to correct these issues and bring consistency to these sections in the GSAR.

501.106 OMB Approval under the Paperwork Reduction Act.
