### **GSA ORDER**

Subject: General Services Administration Acquisition Manual; GSAR Case 2020-G528, Contracting Director Definition Update.

- 1. <u>Purpose</u>. This order transmits a revision to the General Services Administration Acquisition Manual (GSAM) to update the definition of "contracting director" in the context of the Federal Acquisition Service (FAS) Central Office.
- <u>Background</u>. GSAM 502.101 provides definitions of terms appearing throughout the GSAM. The definition of "contracting director" presently includes two outdated Assistant Commissioner titles in the FAS Central Office, and does not include two Assistant Commissioner titles. This GSAM case was initiated to update the list of Assistant Commissioners included under the definition of "contracting director."
- 3. Effective date. Date of Signature.
- 4. <u>Explanation of changes</u>. This amendment includes non-regulatory revisions to the GSAM to reflect changes to the organizational structure within the Federal Acquisition Service. For full text changes of the amendment see Attachment A, GSAM Text Line-In/Line-Out.

## 502.101 Definitions

"Contracting director" means:

(a) Except in the Federal Acquisition Service (FAS), a director of a Central Office or Regional office Division responsible for performing contracting or contract administration functions.

(b) In FAS Central Office—

# [(1) The Deputy Commissioner for Technology Transformation Services or designee;]

[(2)](1) The Assistant Commissioner for [the Office of] Assisted Acquisition Services or designee;

**[(3)]**(2) The Assistant Commissioner for **[the Office of]** General Supplies and Services **[Categories ]**or designee;

**[(4)]**(3) The Assistant Commissioner for Integrated Technology Services[the Office of Information Technology Category] or designee;

[(5) The Assistant Commissioner for the Office of Professional Services and Human Capital Categories or designee; and]

**[(6)]**(4) The Assistant Commissioner for Travel, Motor Vehicle and Card Services**[Travel, Transportation, and Logistics Categories]** or designee; and

**[(7)]**(5) The Assistant Commissioner for **[the Office of Policy and Compliance]**Acquisition Management or designee for support offices with contracting functions.

(c) In FAS Regions, the Assistant Regional Commissioner or designee.
